1. Correction: JEA is amending language contained in the Solicitation document.

#### 1a.) Original Language: Section 1.1.1 SCOPE OF WORK

This Solicitation is for the procurement and replacement of two (2) JEA Standards-approved 8,000-gallon sodium hypochlorite storage tanks for the McDuff Water Treatment Plant (WTP), to include contractor installation and testing services in accordance with the attached technical specification.

#### **Correction: Section 1.1.1 SCOPE OF WORK**

This Solicitation is for the procurement and replacement of two (2) JEA Standards-approved sodium hypochlorite storage tanks for the McDuff Water Treatment Plant (WTP), with a minimum capacity of 8,000 gallons each, expected to fit within the original footprint, and to include contractor installation and testing services without modifications to any structures, in accordance with the attached technical specification.
